He also founded and worked Casa de las Americas, CARI, as chair president and he is a founder of Collective Human Rights Defenders "Laura Acosta" International Organization COHURIDELA, also work at Canadian United Hands International Organization CUHIO. Mario has coauthored the Project of Code Human Rights of Republic of Colombia and she presented project for the establishment of the Ministry of Human Rights in Colombia – his motherland.
